We agree to provide a safe and sanitary boarding environment for your pet. Only pets certified on this agreement by their owners as current on all vaccinations will be admitted. Owners will certify by signature that their pet is current on all required vaccinations and free from communicable diseases. In case of illness or injury that can not be treated by Kennel staff or owners, Kennel agrees to transport the pet to the vet as indicated on this agreement and to contact owner, if possible, to inform them of the need for veterinary attention prior to transportation of the pet. If an emergency is deemed to exist in the professional judgement of the Kennel, immediate transportation of the pet to the vet will occur with subsequent owner contact, if possible. The Kennel will not be liable in any way for veterinary bills resulting from treatment of the pet. Owner is responsible for making payment arrangements with the veterinary clinic. Be aware that pets, especially older pets, are placed under a great deal of stress because of the removal from their normal home environment. This stress can cause latent (dormant) physical conditions (such as heart, liver and kidney disorders) to become active or compromise the immune system resulting in illness such as diarrhea, kennel cough, depression, nervousness, dehydration, and even death. Pets are fed a quality dog/cat food twice a day unless other instructions are left by the owner. Kennel reserves the right to refuse service for any reason. In case owner of pet has not returned to pick up pet within 10 days of agreed date and time set for pick up, Kennel will place pet at a shelter or home of Kennel's choice. If a shelter or a home is not available, the Kennel reserves the right to do whatever is necessary. Kennel does not assume and shall not be held responsible for any liability with respect to the pet listed on this agreement of any kind, character, or nature whatsoever, arising out of or from the boarding of this pet, or any damages which may occur from any cause whatsoever including loss by fire, theft, running away, death, injury to persons, pets, or property, or death or injury to any other pet caused by the within named pet whether this pet be on the premises of the Kennel or not, and the owner of pet agrees hereby to be and is solely responsible for any and all acts of behavior of said pet at any time within the term and time of this agreement. In no case shall the Kennel be in any way liable or responsible. Owner will provide Kennel a detailed medication schedule for all pets admitted with owner noted or anticipated medical problems/conditions. Owner certifies that all medical conditions have been revealed to Kennel. Owner agrees to payment of boarding bill, in full, at time of pet pickup. See board for additional charges and current prices. All pets are provided with their own kennel with or without an outside run. At times, pets are allowed to play with other pets while supervised in an enclosed grassy area. Please let Kennel know if pet does not get along with other pets and/or people. Exercise is provided twice a day in a fenced grass yard. Kennel is not responsible for items brought along with your pet like blankets, beds, toys, etc. You are welcome to bring a mat, blanket, or small bed as long as items are clean and free of parasites. Some toys/chewies left for your pet can be a choking hazard. Your signature indicates that you are aware of this hazard and are willing to take the risk.
